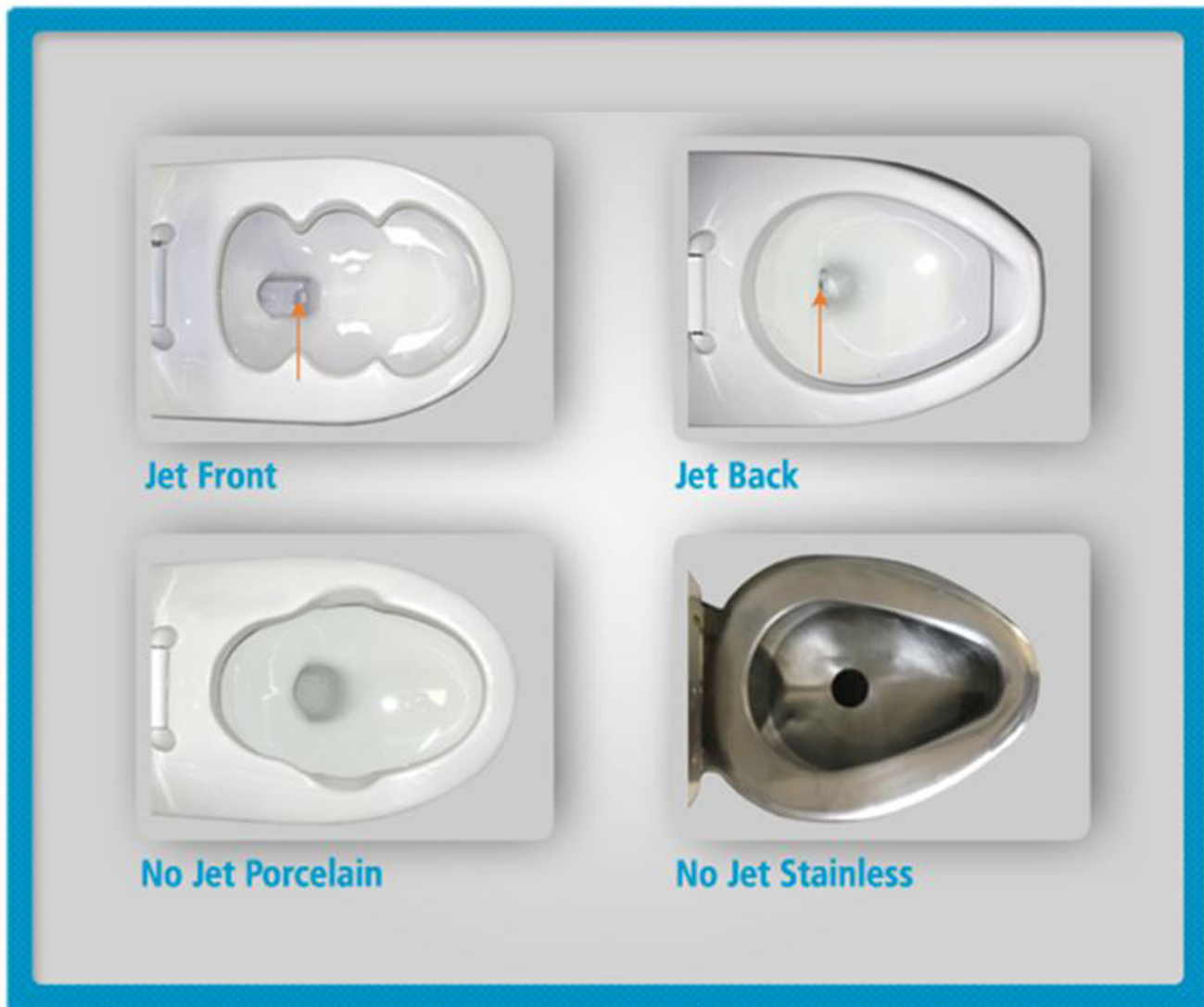




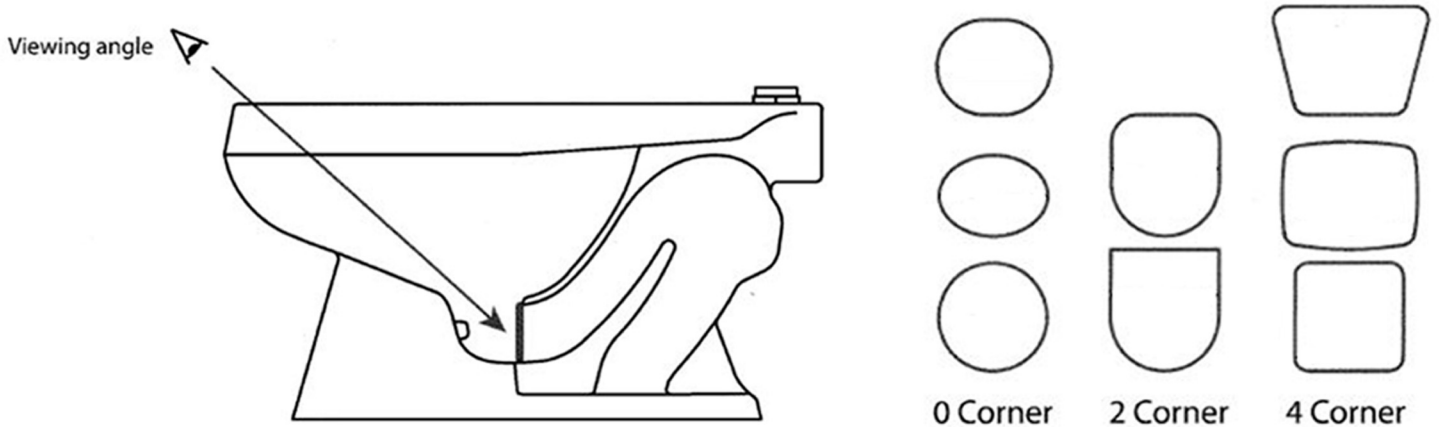
Step 1: Determine Jet Type & Placement. See examples below.

Note that a jet front, 2 corner opening, may have a “step” jet and should be noted

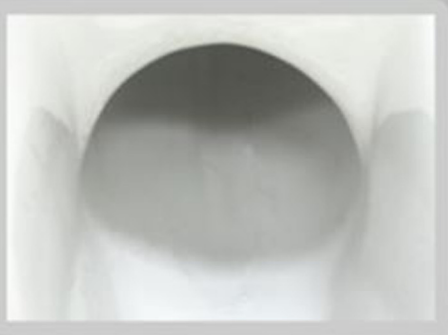


Step 2: Determine if the throat has 0, 2, or 4 corners

Please note that. "Corners" need to be pretty prominent to be considered a corner for sizing.



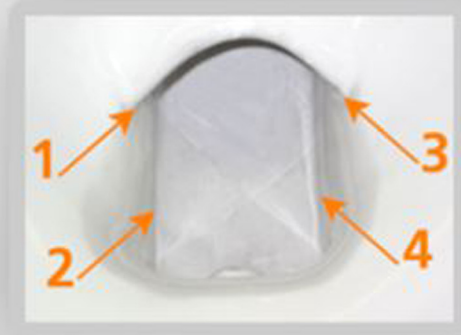

2 Corners

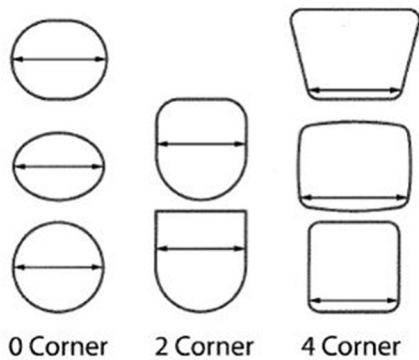


4 Corners

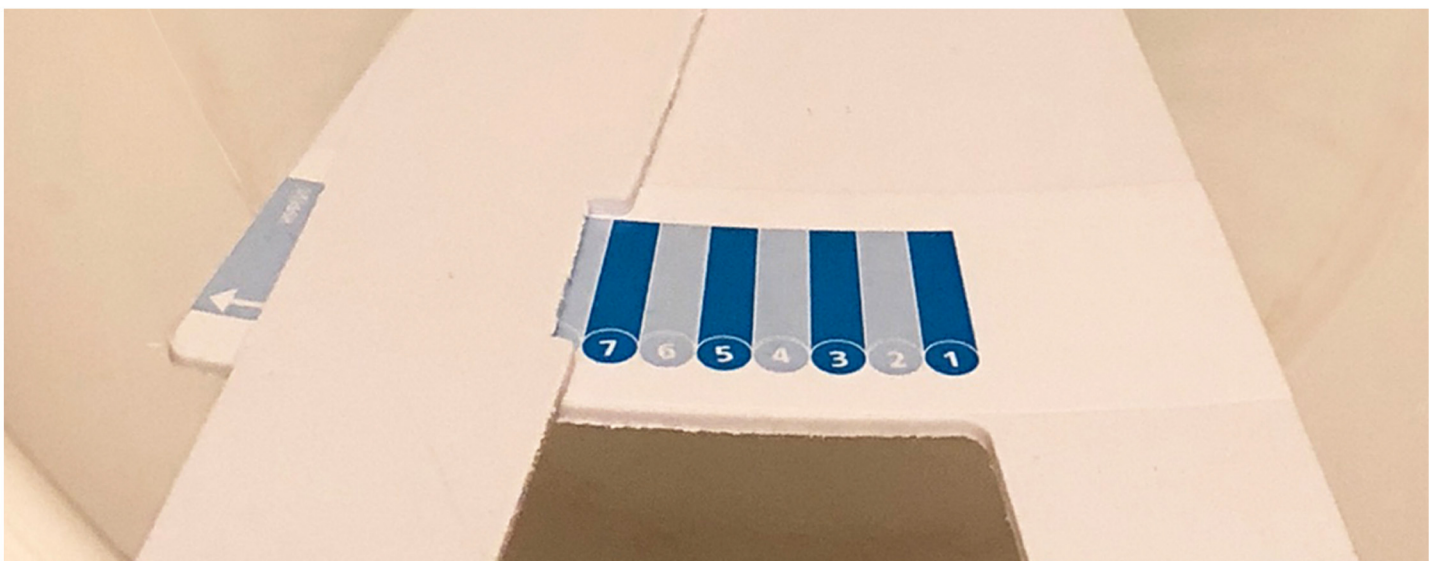
Having trouble determining the number of corners? Send us pictures!

For pictures, we need a front view looking directly at the throat opening, with calm water and no side angle. Having some of the seat/edge of the bowl in the picture helps to give the opening perspective. If it's just zoomed in, we can't really gauge the size of the opening. Please ensure the pictures have good lighting and are high resolution. Send pictures to sales@drainnet.com.

Step 3: Measure the size of the opening using the caliper provided. Place the caliper into the opening as shown.



Where you measure, is determined by the number of corners. The arrow in the diagram below, shows you where to measure.



Read the number at the end of the caliper to determine size. If the caliper is in between 2 numbers always use the smaller of the two.

1. Definitions:

1.1. **Customer.** "Customer" and "Customers" means, individually and collectively, purchasers of Products that are end users of the Products.

1.2. **Product.** "Product" and "Products" means, individually and collectively, the Traptex products sold by Drain-Net Technologies hereto and any other products that Drain-Net Technologies, in its sole discretion, decides to add to this Agreement.

2. End User Agreement: Customer agrees that this product will not be used in a healthcare facility, will not be re-sold, and will not be shipped outside of the USA. If Drain-Net Technologies LLC becomes aware of a violation prior to shipping the product, the order will be canceled, and the customer will be refunded minus credit card fees.

3. Product Liability Indemnification: The Customer shall indemnify and hold Drain-Net Technologies LLC harmless from and against any liability, damage, loss, cost, or expense (including, without limitation, reasonable attorney's fees and expenses necessary to consider, advise, and defend) (collectively, "Liability"), that arises out of or results from: (a) any claims, including claims for property damage, personal injury, or death to the extent that such claims arise directly or indirectly out of, or as a consequence of, the installation of a Product; (b) any claims, including claims for property damage, personal injury, or death, to the extent that such claims are based upon any wrongful or negligent act or omission by Customer (or its employees or agents).

4. Limitation of Liability: Under no circumstances will Drain-Net Technologies LLC be liable to the Customer for special, incidental, indirect, punitive, or consequential damages for any reason. "Consequential damages" includes, without limitation, business interruption; loss of use, revenue, reputation or data; loss or damage to property or equipment; and environmental clean-up.
